Fructose Syrup

The following communication, dated 21 September 2020, is being circulated at the request of the delegation of Indonesia.

Pursuant to Article 12.1(c) of the WTO Agreement on Safeguards, the Government of the Republic of Indonesia hereby notifies the issuance of Minister of Finance's Regulation Number 126/PMK.010/2020 dated 9 September 2020*, promulgated in the Official Gazette of the Republic of Indonesia Number 1017 on 9 September 2020 regarding the imposition of a safeguard measure on the importation of fructose syrup, for a period of 3 years started on 17 September 2020.

1 GENERAL BACKGROUND

On 19 May 2020 the Republic of Indonesia notified the findings of safeguard investigation in which it was concluded that there was an evidence that the increased volume of imports has caused a serious injury to the domestic industry concerned in this investigation (G/SG/N/8/IDN/26 - G/SG/N/10/IDN/26).

It was also indicated in the notification that the Investigating Authority was proposing to the Government of the Republic of Indonesia the imposition of a safeguard measure on the importation of the subject goods.

2 DESCRIPTION OF THE SUBJECT GOODS

The description of the subject goods are as follows:

"Fructose Syrup, under Indonesia Harmonized System (HS.) Code. 1702.60.20."

3 DESCRIPTION OF THE PROPOSED MEASURE

- a. The Government of the Republic of Indonesia has decided to impose the following safeguard duty:

TIMETABLE OF THE SAFEGUARD DUTY

Period	Safeguard Duty
First year (17 September 2020 – 16 September 2021)	24%
Second year (17 September 2021 – 16 September 2022)	22%
Third year (17 September 2022 – 16 September 2023)	20%
