### **6 DEADLINES AND PROCEDURES TO PRESENT EVIDENCE AND VIEWS BY INTERESTED PARTIES**

- (i) Those having substantial interest and wishing to be considered as interested parties in this investigation should submit written request within 15 days from the date of initiation to the Investigating Authority. All submissions and requests made by interested parties must be sent both in a written letter and in electronic format, and must indicate the name, address, email address, telephone and fax number of the interested parties.
- (ii) In accordance with article 3.1 WTO Agreement on Safeguard, the Investigating Authority will conduct a hearing in order to provide opportunities for those WTO Members who have a substantial interest to present their evidence and views. The hearing is scheduled to be held on Tuesday, 31 May 2022 at 10.00 – 12.00 am (GMT+7) via video conference. All interested parties, who wish to participate in the hearing and all written evidence and views, submitted to the Investigating Authority not later than 24 May 2022. Registration on the day of the hearing (31 May 2022) will start at 09.00 am (GMT+7) and only authorized representatives will have access to the hearing.
